You can make a claim for a tax repayment on your PPI interest using form R40 (or form R43 if you are living overseas). Why you may get tax back. If tax is due on PPI payouts, most firms deduct it automatically, at 20 per cent, before you get the money. That has always been an issue for non-taxpayers.

If you pay too much or too little tax over the tax year, HMRC will send you a P800 or a Simple Assessment tax calculation. This will tell you how to get a refund or pay the tax you owe.

The numbers in your tax code tell your employer or pension provider how much tax-free income you get in that tax year. HMRC works out your tax-free Personal Allowance .

If you do not have a PPSN, contact the Department of Employment Affairs and Social Protection (DEASP) to get one. When your employer has your PPSN, they can then request a Revenue Payroll Notification (RPN). This will show your total tax credits, tax rate band and USC rate band. Your employer can then make the correct tax deductions from your pay and take you off emergency tax.
